Northvale Capital Partners Private Limited, Singapore (Acquirer) pursuant to the said Open Offer, became promoter of the Company and acquired 1,74,800 (One Lakh Seventy Four Thousand and Eight Hundred) shares totalling to 6.07% of shareholding in the Target from Public Shareholders. Due to this, Northvale Capital Partners Private Limited added as promoter and there is addition of 174800 shares in Promoter category and same number of shares is reduced from Public category.
